Re: Cliff Electronic Components

To Whom It May Concern:


This firm represents Cliff Electronic Components, Inc. ("Cliff USA") and Andrew Brunt in a lawsuit brought against them by Cliff Electronic Components, Ltd. ("Cliff UK") in the District Court of Shawnee County, Kansas. Cliff UK alleges that both Cliff USA and Mr. Brunt individually are producing and selling counterfeit products. Cliff USA and Mr. Brunt vigorously dispute these allegations and have asked the court to decide a number of issues relating to the ownership rights of CLIFF designs and products. In addition to disputing ownership of the CLIFF trademark, Cliff USA and Mr. Brunt have alleged a number of counterclaims against Cliff UK, including breach of contract, fraud and misrepresentation, misappropriation of trade secrets, tortious interference, and defamation.

It has come to our attention that Cliff UK has sent a number of letters to Cliff USA's customers and suppliers continuing to make these counterfeit allegations against Cliff USA and Mr. Brunt individually. We are disappointed that Cliff UK continues to make these public accusations without waiting for any sort of judicial resolution of its claims, and would like to reassure you that Cliff USA and Mr. Brunt are making every effort to resolve the dispute. They anticipate that their position will be vindicated once the court hears the complete story. **We would further highlight that only CLIFF branded products are involved in the dispute; and Cliff UK does not contest Mr. Brunt's right to sell non-CLIFF branded products.**

A copy of Cliff UK's petition, and of Cliff USA and Mr. Brunt's answer and counterclaims are available from the District Court of Shawnee County, Kansas, 200 SE 7th Street, Topeka, Kansas 66603, which may be contacted at (785) 233-8200. The case caption is *Cliff Electronic Components, Ltd. v. Cliff Electronic Components, Inc. and Andrew Brunt*, and the case number is 08C 1820. A preliminary hearing is scheduled for May 1, 2009, but it may be some time before the court resolves all the assorted issues raised in the pleadings.

Thank you for your attention to this matter, and Cliff USA and Mr. Brunt would further like to thank you for your continued understanding while we work to resolve this dispute.
